The Better Life label criteria include the provision that feed must demonstrably originate from a GMP+ certified feed supplier or a supplier with an equivalent quality assurance system.

An equivalent quality assurance system is an animal feed chain in which all links/companies (including transport) are certified by a quality assurance system that has been accepted by the Dutch Society for the Protection of Animals as an animal feed certificate within the Better Life label scheme.

A list is shown below of quality assurance systems accepted by the Dutch Society for the Protection of Animals as an alternative to GMP+ certification within the Better Life label scheme. Please be aware that, in addition to the production of animal feed, the transport of animal feed must also be covered by certification equivalent to GMP+. In some cases, this may be subject to additional certification or standards.

Transport of animal feed

If the primary participant receives the feed from a certified company (GMP+ or equivalent), transport must comply with the safety requirements for the transport of bulk products destined for animal feed as included in the IDTF (International Database Transport for Feed.)

This can be because:

- transport is certified as part of the quality system (GMP+ FSA, Feed Chain Alliance standard (GMP Animal feeds), QS, FEMAS, UFAS, TASIC, Pastus+ and GTP)
- transport is covered by separate certification (e.g. with a CSA/Oqualim certificate, the transport must be certified by Qualimat). In this case, the additional certification that covers transport must be clearly stated on the delivery note / invoice.
